CONTEST RULES

Article 1 – Organizer

The company MMM! SAS (Organizing Company), 25 boulevard Bonne Nouvelle 75002 Paris, organizes contest (Game) on its website (www.bestnewbistro.com) and its social networks that are free and without obligation of purchase. The competitions and contests take place over several phases on dates to be defined on the website at the URL address "www.bestnewbistro.com" or on the corresponding social networks, and communicated via email to participants who have registered on "www.bestnewbistro.com."

The contest of said competitions are managed and sponsored exclusively by the Organizing Company.

The contest of said competitions are not managed or sponsored by social networks (Facebook, Twitter, Instagram, etc.). The Organizing Company therefore releases the companies operating these social networks from any responsibility concerning all elements linked to the competitions, their organization and their contest.

Article 2 – Eligibility

The contest is open to any persons in the world who are at least 18 (eighteen) years old at the date of entry. Employees of the Organiser and their respective families, also any persons involved directly or indirectly with the design, organisation, contest and management of the contest are not eligible to enter.

To enter the contest, participants must:

- 1/ answer correctly a question about the city of London
- 2/ create an account (last name, first name, email address)
- 3/ vote for a London's restaurant

Only one entry per participant is authorised. It is forbidden to participate from multiple Facebook or other accounts. Participation is personal; it is not allowed to participate from another person's Facebook account. By entering the contest, participants agree to accept these rules fully and unconditionally

Article 3 – Terms and conditions of participation

In order to participate in this competition, every contestant must have registered on "www.bestnewbistro.com" and have therefore entered his/her contact information (last name, first name, email address) so as to allow the organizations to contact him/in her the case of a win.

Any incomplete or incorrect contact information will result in the cancellation of the contestant's participation in the competition. No other means of participation will be accepted. Any participation which is incomplete or not in conformity with the present regulation will not be taken into account and cannot be the object of any claim.

Article 4 – Exclusion of participation

The publications must be in keeping with the theme of the contest and comply with the current legislation; they may not infringe public order or offend public morality. In the event of non-compliance, the publications will automatically be removed from the contest.

In addition, any publication including comments or images denigrating the contest, the product, the Organising Company or, in general, any unethical remarks will be excluded from the contest.

The Organising Company reserves the right to delete, without notice, any publication of a pornographic or discriminatory nature, any publication inciting violence or any not in keeping with the theme or requirements of the contest. Under no circumstances may the Organising Company be held responsible, even partially, for the publications made by the participants nor for their removal.

Article 5 – Prize

There is only one winner and the prize is a voucher for:

- Two nights for two people at the Hoxton Southwark available for one year starting Oct. 28 - value: £600
- One dinner for two on one of the nights of the stay at the London Priceless Best New Bistro for a maximum amount of £200 maximum for two people
- One map with all the London new bistros
- the winner and his/her +1 are invited to the London awards BNB ceremony dinner on Nov. 25th

In the event of force majeure or circumstances beyond its control, the Organizing Company reserves the right to replace the winning prize with a prize of equivalent nature and/or value or to cancel the contest.

Article 6 – Procedures for obtaining the prize

The winner will be picked and reveal on Oct. 28th.after a draw. The winner must respond in the 24 hours following hour of them being contacted by email. If winner who don't reply within this timeframe will be deemed to have waived his/her prize. This prize may then be put back freely into play by the Organizing Company, or given to another participant chosen by a new draw, without it being able to be held liable for this fact.

Any complaints must be made within three months by mail, in a letter that includes the contact information of the contestant, along with the competition and the session in question. After this period, no complaints will be accepted.

Under no circumstances may the prizes be exchanged for other objects, whatever their monetary value, or for a cash sum. If a winner does not or cannot take possession of his/her prize, he/she is not entitled to any other form of compensation.

Article 7 – Liability as it relates to the use of the internet

The organizers cannot be held liable in the case of interruption of service caused by an Internet network incident or by a technical incident beyond their control, if the competition is partially or totally modified, postponed or canceled. No compensation can be claimed because of this.

Article 8 – Protection of personal data

Article 9 – Cancellation/modification of the competition

The Organizing Company reserves the right to cancel, postpone, extend, shorten or modify all or parts of any operations in the case of force majeure or in the case of circumstances beyond its control.

If at the end of the Game, all prizes have not be awarded, the Organizing Company reserves the right to prolong the Game or to once again claim ownership of the prizes to use at its discretion.

At its discretion, the Organizing Company reserves the right to cancel or modify part or all of the present terms and conditions. All modifications of the rules will be subject to an amendment and participants will be informed.

Article 10 – Acceptance and access to the rules and regulations

Participation in any of the Organizing Company's Game implies full and unreserved acceptance of the present rules and regulations.

Any fraud, attempted fraud or non-compliance with the present rules and regulations will result in the immediate and automatic disqualification of its perpetrator, the Organizing Company reserving, where appropriate, the right to bring legal proceedings against them. The use of robots and all other similar methods is prohibited, and the violation of this rule will result in the elimination of its perpetrator, for the entire duration of the Game.
